<p>Proof of family ties with the European Union/EEA/Swiss citizen or of a United Kingdom national</p> <ul style="list-style-type: none"> The spouse: marriage certificate, authenticated with a Hague Apostille. In case of marriage with a Portuguese citizen, the Portuguese marriage certificate must also be provided. The partner: document certifying that the partnership, recognized as equivalent to marriage, has been registered under the law of a Member State. The direct descendants who are under the age of 21: documents establishing family ties: birth certificate ("Extrait d'acte de naissance") or family book ("Livret de Famille"). The direct descendants who are over the age of 21 and are dependants: documents establishing family ties – birth certificate ("Extrait d'acte de naissance") or family book ("Livret de Famille") and proof that they are dependent (e.g. money transfer receipts, payment of tuition fees, bank transfers, etc.).
